BOARD OF ASSESSORS MEETING MINUTES – MARCH 10, 2023

Meeting Via Zoom

Also present: Victor Santaniello Director of Assessments Meeting opened 10:00 a.m.

The meeting began with a review of FY 2023 abatement applications and recommendations made by Director Santaniello. The results are at the end of this report.

Mr. Santaniello then discussed the status of appeals pending at the appellate tax board.

Mr. Ledonne led a discussion about our Wakefield Senior Tax Discount. We discussed our pending home rule petition renewal and potential changes to the state's Senior Circuit Breaker Income Tax Credit and thee effect it will have on our local Wakefield Senior Discount program.

Collectively we discussed the implications of greater benefits to recipients and potential cost to the remainder of the residential tax base. Mr. Santaniello also discussed the effects of too much tax relief and how that would impact a percentage of recipients whereby they may not be able to qualify for the credit in the following year because their tax liability was reduced below qualifying thresholds.

The Board agreed to discuss the matter further once the Commonwealth acted.

The meeting adjourned at 11:25 a.m.
