 - o Dan shared the proposed article that will be on the warrant

 - Ann asked if this law would allow to go from 2 to 4 units by right.
 - Under buffer for parking, Dan asked that if this would alleviate the ZBA from looking at the project so the planning board would oversee
 - Mr. McGrail mentioned that site plan rules to have regulations for the Planning board
 - \circ $\,$ Dan brought emergency lighting for over 15' tall to amend this on the warrant
 - Dan suggested that the language should suggest only new buildings to have the facade face the principal street. Existing buildings may not be this way, they could go to the Planning Board if they didn't meet the requirements
 - Tim brought up that we not give too much discretion and we should leave well enough alone.
 - Brian aggreged, if we add to much discretion for boards to hear, it may not pass
 - Dan question paragraph f of site plan review, D size sheets, wanted to add electronically submitted
 - o Dan will send off comments to Bobrowsky and Tom Mullen

- Dan proposed having maybe 2 maps, this and a smaller one just in case it doesn't pass
- Joe mentioned that this may be a bad idea that it may look like we are moving the goal posts if the discussion is not going well
- Tim thought it was a good idea just so we could get it passed on the first go around
- All in all this draft was consistent with our bylaws
