Partial funding of WCAT through Fiscal 2024 through ARPA grant

- Eric gave an overview of himself.
 - \circ He was involved in the cable committee back in 1973.

Patty Bianchet – on the board for 6 years

Brian is volunteer with the WCAT.

Ian is the chief engineer for WCAT.

Open items:

WCAT welcomed us to see the office.

- Where will WCAT be located regarding the new high school?
- Like the students- the new office will be ready before demolition of the old space
- Drops and space will be part of the design of the new high school, unlike the Galvin.
- Ryan said the new space is adequate for WCAT needs.
- Discussions are just beginning make sure WCAT is part of the redesign.
- WCAT's services are very important and needed.

Shane asked when the next round of negotiations will be.

- Verizon Fios is currently every 5 years.

- They may get rid of the "cable component" and just do streaming service.

Brendon asked about the funding of WCAT.

- Ryan sees funding continuing to fall.
- Solution is to get a specific portion of the streaming services for local access stations, like WCAT.
- Ryan gave history of the Cable ACT that passed in 1986.
 - \circ Franchise fee of up to 5%
- Federal legislation is out of date.
- These need to be updated.
- Cable companies pay "rights to town" currently out of date and from Cable Act
 - "Broadband bill" Limits town and bypasses the Cable Act (and \$\$)
- Bill Readings new role will help with this
- In the end, WCAT has high quality content for the town
 - We need money to continue to support this
 - Decease of 3 4 % revenue each year with increase of costs of 3-4% annually
