VSO March 2024 Report and Veterans Coffee: The Veterans monthly food and dry goods support program will be held tomorrow Wednesday, March 20th, behind the senior center. Twenty-seven applicants received food selections from the Greater Boston Food bank assembled by volunteers from Wakefield and the surrounding communities of Stoneham, Saugus, Melrose, North Andover, and the Melrose fire Dept.

- The Wakefield Elks lodge #1276 held a breakfast for Veterans last Saturday March 16th at 10 am and donated \$4,000 for the Wakefield Veterans relief fund bringing our total to date to \$16,000. The turnout was excellent with over 70 participants. Elks invest in their communities through programs that help children grow up healthy and drug-free, meet the needs of today's Veterans, and improve the quality of life.
- We were fortunate to have the Veteran who we elected to give the financial support to last month
 for her oil delivery instead, fall into the category for the "LEO" program. LEO's Fuel Assistance
 program assists low-income households in Lynn, Lynnfield, Nahant, Saugus, Swampscott, and
 Wakefield by subsidizing and accessing discounts for participants.

CHAPTER 115

As I have mentioned each month Under Chapter 115 of Massachusetts General Laws the Commonwealth provides a uniform program of financial and medical assistance for veterans and their dependents.

<u>Qualifying</u> veterans and their dependents receive necessary financial assistance for food, shelter, clothing, fuel, and medical care on a monthly basis in accordance with a formula that takes into consideration the



number of dependents and income from all sources. For those on a Medical only category, prescription drugs are reimbursed, and if they qualify for MassHealth buy in, we can assist in getting the application.

If a Veteran or the spouse of a Veteran or family member wishes to apply for the Veterans DD 214 (discharge documents) if they enlisted in Massachusetts active duty, my office is capable of retrieving it or can submit the documents to the National Records Center. In many cases the document is required for many of the benefits through the VA. Including chapter 115.

Veteran Relief Fund

The Veteran Relief fund now has a balance of \$16,000 and can be made available to Wakefield Veterans, Veteran families or Spouses of surviving Veterans who fall into or become financially strapped and need a one-time assist for reasonable financial help. The requirement is they will need to submit prior three-month bank statements, (savings statements included) information on any investment holdings that are redeemable, and the invoice or need for the assistance. The advisory board will need to vote on the disbursement to establish the release of funds.
