2. Minutes Approval

d. Motion to approve the March 6, 2024 Fire Department Sub- Committee meeting minutes by Dennis Hogan seconded by Tarae Howell and so voted.

3. Budgets were reviewed with the following noteworthy comments:

I) Fire Department:

The budget is increased by \$748,637 over the FY2024 Budget to \$7,466,154. The primary drivers were the ending of the SAFER grant (\$297,200) as well as settlement of the new Fire Department Union Contract.



II) Department of Public Works

The Increase over the 2024 Budget was \$281,489 to \$7,252,058. Snow and Ice is level funded at \$850,000. The projected FY 2025 Water budget is \$7,470,570. And the projected FY2025 Sewer Budget is \$9,367,204.

III) School Department

Superintendent Lyons provided an initial review of the proposed School Budget. The projected amount for FY2025 is \$52,310,699 from tax levy an increase of 5.5% over FY2024. Dr. Lyons indicated that the budget did not include any new full-time positions but did include funding for the recently settled Teacher Union Contract. Dr. Lyons also indicated that as of this date, he did not anticipate utilization of the Special Education Stabilization Fund to cover any budget shortfalls in that area.

4. Committee Comments:

Chairman Sullivan thanked the sub-committees for their work and reminded that all meetings needed to be posted and that minutes needed to be completed. Also, that the sub-committee should present to the Town Council during the budget presentation.

Dan Sherman shared his most recent forecast including budgets reviewed to date. Steve Maio shared expected amounts for the Vocational Schools and Group Insurance budgets.
