Jim Hogan gave an overview and went over the mixed use overlay map. Matt Lowry spoke as a member of the working group. The State is mandating more rights to homeowners by right and sees this as an opportunity for downtown revitalization. Bill Spaulding, Kevin York and Theo Noell spoke in support of this overlay map.

Jim Hogan presented the Bylaw being Proposed for Town Meeting Article as well as Erin Kokinda explained what she went over with Town Engineer Bill Renault. He raised a few concerns he had on the Bylaw-specifically about parking. The PB discussed parking buffers between property lines and buildings as well as safety entering and exiting lot. Plantings, lighting, height and stormwater management were also gone over briefly.
