SUPPLEMENTAL REGULATION REQUEST - CORRECTION OF ERRORS

The Board members were in receipt of wording options for a new supplemental regulation regarding the correction of errors. Daniel Sherman motioned to send the following new supplemental regulation to PERAC for approval seconded by Daniel Calore and so voted with Richard DeFelice abstaining.

Correction of Error Under G.L. c. 32, 20(5)(c)(2)

In all cases of correction of an underpayment or non-payment of a pension or benefit to a member or beneficiary of the Wakefield Retirement System which results in a onetime retroactive payment of benefits, such payment shall include interest for such period of underpayment or non-payment at the rate of three percent (3%).

In all cases of correction of an overpayment of a pension or benefit to a member or beneficiary of the Wakefield Retirement System, the amount of overpayment shall be due from the member or beneficiary, along with interest for said period of overpayment at the rate of three percent (3%).

Pursuant to the judgment of the Supreme Judicial Court in *Herrick v. Essex Regional Retirement Board*, 465 Mass. 801 (2013) and PERAC Memorandum #32, 2013, said interest shall be deemed to be the actuarial equivalent of the adjustment to the pension or benefit as required by G.L. c. 32, § 20(5)(c).

Philip Rogers, Sr. brought up the Michael Petrucci incident that happened during the August 25, 2016 Retirement Election. Mr. Rogers did not like what happened and does not want this to happen again. The Board members asked what he was referring to. Cathy explained that Michael Petrucci was loud, crude and intimidating, laced with personal attacks and profanity because of the flyers of the candidates that were posted in the hallway outside of the election room. Daniel Calore suggested that a letter be sent to Mr. Petrucci and cc'd to the Town Administrator and the Selectmen regarding his behavior. Philip Rogers, Sr. and Daniel Sherman agreed that a letter needs to be sent. Daniel Calore volunteered to write the letter and send it to the Board members and Cathy and Sherri to review before Cathy mails it out.

Richard DeFelice asked what the Board is going to do about the request from Matthew Maglio. Chairman Gill replied that at the last Board Meeting of September 22, 2016 the Board voted to take no action regarding Mr. Maglio's request for regular compensation for mandatory overtime.
