Raffle and Bazaar Permits Information Sheet

A raffle is defined in M.G.L. c.271 §7A as an arrangement for raising money by the sale of tickets, certain among which, as determined by chance after the sale, entitle the holder to prizes.

A bazaar is defined in M.G.L. c.271 §7A as a place maintained by the sponsoring organization for disposal by means of chance one or both of the following types of prizes (1) merchandise of any value (2) cash awards, not to exceed \$250 each.

Qualified Applicants

The law requires that the promotion and operation of the raffle be limited only to the qualified members of the sponsoring organization and no such member shall receive compensation in any form for their time or effort devoted to the promotion and operation of such raffle. In addition, all raffle proceeds must be used for educational, charitable, religious, fraternal, or civic purposes or for veterans' benefits.

The organization must be organized and actively functioning as a nonprofit in Massachusetts for at least two years. Qualified applicants are:

- a veterans' organization chartered by the Congress of the United States or included in clause (12) of section five of chapter forty of the General Laws;
- a church or religious organization;
- a fraternal or fraternal benefit society;
- an educational or charitable organization;
- a civic or service club or organization; and
- clubs or organizations organized and operated exclusively for pleasure, recreation, and other nonprofit purposes, no part of the net earnings of which inures to the benefit of any member or shareholder.

Application

1. Complete a permit application and submit it to Wakefield's Town Clerk. The filing fee in Wakefield is \$10.
2. The Town Clerk forwards the application to the Chief of Police who decides whether or not to endorse it.
3. If endorsed by the Police Chief, it is returned to the Clerk who issues the permit.
4. The Clerk issues a permit valid for one calendar year and sends a copy to the Commissioner of Public Safety and to the Lottery Commission.
5. The Lottery Commission sends a financial form for the organization to complete within 10 days after the raffle is completed.
6. If the application is not endorsed by the Chief of Police or not approved by the Clerk within 30 days of applying, the organization may seek judicial review in the District Court.
