BOARD OF SELECTMEN - July 16, 2012

The meeting of the Board of Selectmen was posted and held at the WCAT Studios, 64 Hemlock Road, Wakefield, MA, with Selectwoman Betsy Sheeran presiding, Selectman Patrick S. Glynn, Selectman John B. Encarnacao, Selectman James E. Good and Selectman Brian E. Falvey and Selectman Paul R. DiNocco in attendance. Town Administrator Stephen P. Maio and Town Counsel Thomas A. Mullen was also present. Selectman Tiziano Doto was absent.

Chairwoman Sheeran called the meeting to order at 7:15 p.m.

Chairwoman Sheeran stated that there is a need for Executive Session to discuss contract negotiations with a non represented party because an open meeting may have a detrimental effect on the negotiating position of the Town. Selectman Good so motioned, seconded by Selectman DiNocco and so voted.

At 7:30 p.m. the Board entered into open session and Chairwoman Sheeran called the meeting to order.

Selectman DiNocco motioned to accept the Board Minutes of June 25, 2012, seconded by Selectman Glynn and so voted.

Selectman DiNocco motioned to appoint Sherri Eskenas as the Clerk to the Board of Selectmen, seconded by Selectman Glynn and so voted.

Bob Charleton was before the Board for Public Participation. He informed the Board that he would no longer be covering the meetings for the Chronicle and wanted to officially thank the Board for all the help that they have given him.

Victor Santaniello Director of Assessments was before the Board regarding the senior tax exemption and increasing the amount of the exemption for qualified home-owners from \$750.00 a year to \$1,000.00 a year. Selectman DiNocco motioned to approve the increase amount from \$750.00 a year to \$1,000.00 a year, seconded by Selectman Glynn and so voted.

Victor Santaniello Director of Assessments was before the Board regarding the Inter-Municipal Agreement with the Reading Director of Assessing functions. Mr. Santaniello stated that the Inter-Municipal Agreement will be reviewed annually and that this Agreement has an expiration dated of January 1, 2014. He also noted that the saving to Wakefield would be \$35,000.00 per year. Selectman Glynn motioned to approve the Inter-Municipal Agreement with Reading, seconded by Selectman DiNocco and so voted.

Town Administrator Stephen P. Maio presented to the Board the following bonds:

<u>Voted</u>: that the sale of the \$6,783,000 General Obligation Municipal Purpose Loan of 2012 Bonds of the Town dated July 18, 2012 (the "Bonds"), to Roosevelt & Cross, Inc. at the price of \$7,409,349.81 and accrued interest, if any, is hereby approved and confirmed. The Bonds shall be payable on August 1 of the years and in the principal amounts and bear interest at the respective rates, as follows:

<u>Further Voted</u>: to approve the sale of a \$400,000 0.75 percent General Obligation Bond Anticipation Note of the Town dated July 19, 2012, and payable November 16, 2012 (the "Note"), to Eastern Bank at par.

<u>Further Voted</u>: that in connection with the marketing and sale of the Bonds, the preparation and distribution of a Notice of Sale and Preliminary Official Statement dated June 29, 2012, and a final Official Statement dated July 10, 2012 (the "Official Statement"), each in such form as may be approved by the Town Treasurer, be and hereby are ratified, confirmed, approved and adopted.

<u>Further Voted</u>: that in connection with the marketing and sale of the Note, the preparation and distribution of a Notice of Sale and Preliminary Official Statement dated June 29, 2012, and a final Official Statement dated July 10, 2012, each in such form as may be approved by the Town Treasurer, be and hereby are ratified, confirmed, approved and adopted.

<u>Further Voted</u>: that the Bonds shall be subject to redemption, at the option of the Town, upon such terms and conditions as are set forth in the Official Statement.

<u>Further Voted</u>: that the Town Treasurer and the Board of Selectmen be, and hereby are, authorized to execute and deliver continuing and significant events disclosure undertakings in compliance with SEC Rule 15c2-12 in such forms as may be approved by bond counsel to the Town, which undertakings shall be incorporated by reference in the Bonds and Note, as applicable, for the benefit of the holders of the Bonds and Note from time to time.

<u>Further Voted</u>: that we authorize and direct the Treasurer to establish post issuance federal tax compliance procedures in such form as the Treasurer and bond counsel deem sufficient, or if such procedures are currently in place, to review and update said procedures, in order to monitor and maintain the tax-exempt status of the Bonds and Note.

<u>Further Voted</u>: that each member of the Board of Selectmen, the Town Clerk and the Town Treasurer be and hereby are, authorized to take any and all such actions, and execute and deliver such certificates, receipts or other documents as may be determined by them, or any of them, to be necessary or convenient to carry into effect the provisions of the foregoing votes.

Selectman Encarnacao so motioned, seconded by Selectman Glynn and so voted.

At 8:00 p.m. Selectman Glynn motioned to open the Public Hearing for Laurie's 9:09 Raw Bar & Steakhouse for an All Alcohol License, seconded by Selectman DiNocco and so voted. Roll Call:

Selectman Falvey motioned pursuant to M.G.L. c138 §16c that the granting of the license is determined not to be detrimental to the educational and spiritual activities of any school or church, seconded by Selectman Glynn and so voted.

At 8:20 p.m. Selectman DiNocco motioned to close the Public Hearing, seconded by Selectman Glynn and so voted.
