## BOARD OF SELECTMEN – February 10, 2014

The meeting of the Board of Selectmen was posted and held at the WCAT Studios, 24 Hemlock Road, Wakefield, MA, with Chairman Tiziano Doto presiding, Selectman Paul R. DiNocco, Selectwoman Phyllis J. Hull, Selectwoman Ann McGonigle Santos in attendance. Town Administrator Stephen P. Maio and Town Counsel Thomas A. Mullen were also present as well as Clerk to the Board of Selectmen Sherri Eskenas. Selectman Brian E. Falvey, Selectman Patrick S. Glynn and Selectwoman Betsy Sheeran were absent.

Department Head in attendance was Kevin Gill, Town Accountant.

Chairman Doto called the meeting to order at 7:30 p.m.

Selectman DiNocco motioned to accept the Regular Board Minutes of January 27, 2014, seconded by Selectwoman Santos and so voted.

Selectman DiNocco motioned to appoint James Lapery of 241 Salem Street to the Permanent Building Committee with a term expiration date of December 31, 2016, seconded by Selectwoman Hull and so voted.

Selectwoman Hull motioned to approve the Street Lights Budget in the amount of \$213,131.00 as presented by Kevin Gill, seconded by Selectman DiNocco and so voted.

Selectman DiNocco motioned to approve the Historical Commission Budget in the amount of \$1,100.00 as presented by Kevin Gill, seconded by Selectwoman Santos and so voted.

Selectman DiNocco motioned to approve the Medicare Budget in the amount of \$572,960.00 as presented by Kevin Gill, seconded by Selectwoman Hull and so voted.

Selectwoman Hull motioned to approve the Unemployment Budget in the amount of \$75,000.00 as presented by Kevin Gill, seconded by Selectman DiNocco and so voted.

Selectwoman Santos motioned to approve the Reserve Fund Budget in the amount of \$300,000.00 as presented by Kevin Gill, seconded by Selectman DiNocco and so voted.

Selectwoman Hull motioned to approve the Professional/Medical Budget in the amount of \$8,350.00 as presented by Kevin Gill, seconded by Selectman DiNocco and so voted.

Selectwoman Hull motioned to approve the Statement of Interests as presented on the Wakefield Memorial High School and the Greenwood School, seconded by Selectman DiNocco and so voted.

Town Counsel Thomas Mullen presented to the Board the Order of Taking for Carriage Lane which was passed at the November 13, 2013 Regular Town Meeting for the acceptance of Carriage Lane as a public way.

Selectwoman Santos motioned to approve the Order of Taking for Carriage Lane as presented, seconded by Selectwoman Hull and so voted.

Selectwoman Hull motioned to approve the request of \$250,000.00 for the snow and ice overdraft, seconded by Selectwoman Santos and so voted.
