



Notice of Meeting Minutes: Town Council 2023 November 27 7:00 pm Eastern Time WCAT Studio – 24 Hemlock Road | Via Zoom

Call to Order: Jonathan P. Chines called the meeting to order at 7:00 p.m.

Pledge of Allegiance: Jonathan P. Chines led the body in the reciting of the Pledge of Allegiance.

Town Council: Mehreen N. Butt, Jonathan P. Chines, Chair; Anne P. Danehy (remote); Edward F. Dombroski, Jr., Michael J. McLane, Vice Chair; Julie Smith-Galvin; and Robert E. Vincent II.

Administration: Stephen P. Maio, Town Administrator; Sherri A. Dalton, Executive Assistant, and Town Council Clerk.

Town Counsel: Thomas A. Mullen.

Presentations / Updates: Flag Policy Update Proposal: Michael J. McLane proposed the latest iteration of the Flag Policy. While the proposed policy would have continued to allow the flying of the Pride and Juneteenth flags in June on the second flagpole at the Americal Civic Center, the policy also proposed flying the Americal Division flag at the Americal Civic Center on one of the flagpoles at all times except for June. After a lengthy discussion, Michael J. McLane moved to adopt the Flag Policy's proposed iteration. Mehreen N. Butt seconded. Edward F. Dombroski, Jr. moved to amend paragraph 5a - on Flag Day, June 14th, only the USA Flag, POW/MIA Flag, and General Galvin flag shall be flown to commemorate Flag Day. Michael J. McLane seconded. Anne P. Danehy moved to amend the amendment - paragraph 5a Flag Day event takes place and that only the American Flag, POW/MIA Flag, and General Galvin flags are flown; and paragraph 5c Pride Flag will fly at the Americal Civic Center every day except for Flag Day and when the Juneteenth Flag is flown. Michael J. McLane seconded. Robert E. Vincent II moved to postpone the vote indefinitely. Julie Smith-Galvin seconded. At 8:04 p.m., Julie Smith-Galvin stated she had an emergency and needed to leave but did not return. The motion to postpone failed 3-3-0, with Anne P. Danehy, Edward F. Dombroski, Jr., and Michael



J. McLane voting against the motion. Robert E. Vincent II, Jonathan P. Chines, and Mehreen N. Butt voted in favor. The motion to amend the amendment failed 2-4-0, with Anne P. Daney and Michael J. McLane voting in favor. Robert E. Vincent II, Mehreen N. Butt, Edward F. Dombroski, Jr., and Jonathan P. Chines voted against the motion. The motion to amend the proposed motion failed 2-4-0, with Michael J. McLane and Edward F. Dombroski, Jr. voting in favor of the motion. Anne P. Danehy, Robert E. Vincent, II, Mehreen N. Butt, and Jonathan P. Chines voted against the motion. The motion to adopt the proposed iteration of the Flag Policy failed 3-3-0, with Robert E. Vincent II, Mehreen N. Butt, and Jonathan P. Chines voting in favor of the motion. Anne P. Danehy, Edward F. Dombrowski, Jr., and Michael J. McLane voted against the motion. The current Flag Policy stays in effect until and unless the Town Council proposes another iteration. Strategic Planning Position Update: Town Administrator Maio provided an update on the Strategic Growth and Development position. He stated that 26 applications were received, and 24 needed more experience. The advertisement was reworked, and 16 applications were received. Seven of the applications have direct planning experience. The screening committee consisting of Human Resource Director Forziati, Town Engineer Renault, Community and Economic Development Director Kokinda, and Executive Secretary and Town Council Clerk Dalton will schedule interviews in the next few weeks, and finalists will be presented to him for the second round of interviews. Wakefield Memorial High School: Michael J. Mehreen N. Butt seconded. The motion passed 6-0-0 by roll call vote.
