## 2) Water/Sewer Rate Review Recommendations

- Mr. Stinson presented various rate analysis for Water and Sewer rates with options for FY2020, noted article needed at Town Meeting for Sewer Rates to change language.
- Mr. Stinson mentioned if not enough money is raised would need to borrow from tax Levy.
- Budget is voted at Town Meeting at a fixed revenue
- Letter being sent to Town Council with recommendations on rate varies on options.
- \$7.25 water rate projected at \$5,122.00 yearly end earnings, \$7.30 water rate projected at \$40,776.00 yearly end earnings, noted at \$7.25 would need to hit projected consumption revenue otherwise would be lower.
- Ms. Proakis asked if there could be a way to charge differently for large users, Mr. Stinson explained a cost analysis would need to be done for large users before options could be provided.
