- 1) Call to order at 5:05 pm
- 2) Public Participation
  - None
- 3) Approval of March 9, 2020 Minutes

- 5) COVID-19, Town Meeting Date, FY21 Budget, Capital

- 6) Water Rate Study
  - Mr. Conway presented information for the Abraham Group whom was awarded the bid contract; they have received data from Public Works and will follow up with the Advisory Board of Public Works at a future meeting
  - Ms. Waitt mentioned phase 2 will be starting around May 9, 2020
  - Vice Chair Ms. Palomnio asked what the Abraham Group would do to assist in mitigating abatements, Ms. Waitt explained they'll be looking at all factors for billing process

  - Vice Chair Ms. Palomino read that there is a shortage of CO2 effecting water supply, Ms. Waitt said that the MWRA had not reported such issues in our area at this time
  - Chair Mr. Tarr mentioned Town Councilor Butt spoke about upcoming textile program and how residents can obtain additional bags, Ms. Waitt explained Simple Recycling can work with the resident directly
