## **Nicotine-Free Generation Public Hearing:**

Proposed changes to the Wakefield Board of Health tobacco regulations include, but are not limited to, the following:

1. "Prohibition of Sales – No person, firm, corporation, establishment, or agency shall sell tobacco or ecigarette products to anyone born on or after 1/1/2004.

Any person, firm, corporation, establishment, or agency who or which shall violate any provisions of this regulation and upon written notification shall be fined and suspended in accordance to the schedule set forth under the Regulation of the Wakefield Board of Health Restricting the Sale of Tobacco Products."
