## ----- TOPICS OF DISCUSSION -----

The Wakefield Board of Health held their monthly meeting on Monday, February 13, 2017 at WCAT Studios 24 Hemlock Rd, Wakefield, MA 01880.

**Call to Order** Chairperson Gourville called the meeting to order at 6:30 pm.

Approval of<br/>MinutesGourville moved to approve the minutes as presented. Mehlman seconded.<br/>Motion passed 3-0-0.

Variance John and Christine Murray the owners of 43 Cooper St Ext were present. They are requesting a variance from Section 310CMR15.411 (1) b to build a garage within ten (10) feet from their septic system. The garage would be built as close as 6 feet from the septic tank which would require a 4 foot variance to the current regulations of 10 feet. The septic tank would be marked during construction to avoid any equipment breaking it during construction. Mehlman motioned to grant the variance. Silva seconded. Motion passed 3-0-0.

Variance request Micro-blading
 Anna Frongillo owner of Bella Mano and Matthew Frongillo were present. Anna Frongillo is requesting a variance from Section 12 (5) of the Body Art regulations. She proposes to perform microblading. The regulations require that an individual to have 2 years of apprenticeship. The variance request is to be able to perform this service without the 2 year apprenticeship but only after receiving a certificate in Micro-blading. She does not feel that the A&P course is relevant to micro blading. Mehlman moved to waive the A&P course and 2 year apprenticeship with the condition that Frongillo will complete the micro blading course presented. Silva seconded. Motion passes 3-0-0.
