19, 2017.

Call to Order Chairperson Gourville called the meeting to order at 7:00 pm.

Approval of Minutes Silva moved to approve the minutes as presented. Mehlman seconded. Motion

passed 3-0-0.

Preliminary Subdivision 107 Prospect St The BOH reviewed plans submitted to the Health Department for a proposed

subdivision at 107 Prospect St. The Board has no comment.

Variance request-Farmland Lisa Berger a food safety consultant representing Farmland sent a letter to the BOH requesting a variance so they may conduct reduced oxygen packaging (vacuum packaging of beef, lamb and poultry). They are also requesting a variance so that they may use the 2013 FDA Food Code Section 3-502.12 as this includes the most up-to-date recommendations for the shelf life of vacuum packed raw meat and poultry. The BOH reviewed the most recent inspection reports for Farmland. Mehlman moved to deny the variance request Silva

seconded the motion. Motion denied 3-0-0.

Colonial Point Variance Request The BOH received a letter from Fred Levitan of Colonial Point 95 Audubon Rd requesting a variance from code 105CMR410.201 (Heating requirements) They are requesting to turn off the heat as of May 31st to keep the building at a more comfortable temperature and get ready to supply AC at the property. Gourville motioned to grant the variance. Mehlman seconded. Motion passes 3-0-0.

Lakeside Inn Pool Variance

The Lakeside Inn has requested a variance from the pool code 105CMR435.05(3). Gourville motioned to grant the variance. Mehlman seconded. Motioned passed 3-
