**Call to Order** 

Chairperson Mehlman called the meeting to order at 7:01 pm.

Approval of Minutes

Mehlman motions to table minutes of May29, 2019, seconded by Gourville. Motion passes 2- 0.

Variance Request: Keeping of Animals 8 Webster Linda Govostes-ONeil of 8 Webster st Wakefield was present. Govostes-O'Neil is requesting a variance to have 6 chickens. She has notified all of her abutters, one abutter was not happy as the coop was not 50 ft. from the required property line, another abutter is the Town of Wakefield conservation land and the third has signed the letter of notification of intent to have the chickens. They are moving the coop and will add additional heavy duty black fencing. Clay said the coop is protected. Gourville motions to grant the variance, Mehlman seconded the motion. Motion passes 2-0-0.

Definitive Subdivision: Forest Street a/k/a Lovis Ave Ext

Clay explained the plans of the new subdivision of Lovis Ave to the Board of Health. Gourville motions to approve the current plans for Lovis Ave as presented, Mehlman seconded the motion. Motion passes 2-0-0.
