BOARD OF SELECTMEN – October 14, 2015

The meeting of the Board of Selectmen was posted and held at the WCAT Studios, 24 Hemlock Road, Wakefield, MA, with Chairwoman Ann McGonigle Santos presiding, Selectwoman Betsy Sheeran, Selectman Paul R. DiNocco, Selectman Patrick S. Glynn and Selectwoman Phyllis J. Hull in attendance. Town Administrator Stephen P. Maio and Clerk to the Board of Selectman Sherri A. Dalton were also present. Selectman Tiziano Doto and Selectman Brian E. Falvey were absent.

Chairwoman Santos called the meeting to order at 7:30 p.m.

Police Chief Richard E. Smith appeared before the Board and spoke about what would be his new position as Vice President at Large of the International Association of Chiefs of Police (IACP) which he will be sworn in as on October 27, 2015. Chief Smith stated that it's a great opportunity for him and that he can bring a lot of information back that will certainly help Wakefield. As vice president at large, Chief Smith will oversee a number of IACP committees including Juvenile Justice and Child Protection, Community Policing, Victim Services and the Private Sector Liaison Committee and that his role will be to provide oversight and direction on how to incorporate their work into mainstream policing. Chief Smith made it perfectly clear to Town Administrator Stephen P. Maio before pursuing his new role with the IACP that Wakefield is his job and his life for the next three years and that nothing is going to interfere with that. All the selectmen congratulated and gave their support to Chief Smith.

Selectwoman Sheeran motioned to appoint Faith Hodgkins of 25 Woodcrest Drive to the Sweetser Lecture Committee, seconded by Selectman DiNocco and so voted.

Selectwoman Sheeran motioned to appoint Jerry Hammersley of 4 Rivers Lane and Jason Cohen of 2 Washington Avenue to the Permanent Building Committee with terms expiring April 30, 2018, seconded by Selectman DiNocco and so voted.

Selectman DiNocco motioned to appoint Michael Salvatore of 11 Essex Street to the Albion Cultural Exchange Committee with a term expiring April 30, 2018, seconded by Selectwoman Sheeran and so voted.
