BOARD OF SELECTMEN – November 09, 2015

The meeting of the Board of Selectmen was posted and held at the WCAT Studios, 24 Hemlock Road, Wakefield, MA, with Chairwoman Ann McGonigle Santos presiding, Selectwoman Betsy Sheeran, Selectman Paul R. DiNocco, Selectman Patrick S. Glynn and and Phyllis J. Hull in attendance. Town Administrator Stephen P. Maio, Town Counsel Thomas A. Mullen and Clerk to the Board of Selectman Sherri A. Dalton were also present. Selectman Tiziano Doto and Selectman Brian E. Falvey were absent.

Chairwoman Santos called the meeting to order at 7:30 p.m.

Town Administrator Maio proposed three areas that Wakefield could enter into a compact with the state in an effort to improve practices. One areas would be housing and economic development. Another area would be assistance with evaluating the town and how competitive it is compared to other communities in attracting commercial development and housing expansion. And another area is improving ways of making town budget and financial data more available to the public electronically via the Internet.

Selectman Glynn motioned that Town Administrator Maio go forward in partnering with the state for the Community Compact program, seconded by Selectwoman Sheeran and so voted.

Selectman DiNocco motioned to approve the request from Sharon Gilley, Director of the Lucius Beebe Memorial Library to accept and expend a gift or gifts to the library in the amount of \$840.00 from various donors with thanks, seconded by Selectman Glynn and so voted.
