Item #1: Call to Order

Ann Santos agreed to take the minutes.

Item #2: Public Engagement: Public Participation: Paul Cancelliere

<u>Item #3</u>: Minutes from September 19, 2022: Approval with minor change re: roll call vote taken and time of adjournment. Roll Call vote for approval of minutes: 5 in favor; 0 against; 2 abstentions. Minutes from August 15, 2022 not yet ready to be reviewed.

Item #4: Review Bylaws:

- Chapter 9 (Boards, Committees, and Commissions)
 - Town Counsel Tom Mullen reported that he had not received any updates for any Boards.
 - Paul Cancelliere represented Veteran's Advisory Board with suggestion that VAB be listed under Chapter 9 as it has been in existence since 2012.
 - Tom Mullen advised Mr. Cancelliere that bylaws were not needed to formalize membership rather regulations including membership; transitions; operations; etc. could be drafted and presented to Town Council. Recommended that the VAB work with Tom Mullen and their Town Council Liaison to draft regulations to present before the Town Council.
 - Chair Lieber supported recommendation, noting that creating regulations supports clarity and expectations of membership for VAB and suggested they examine the abandonment and attendance sections in Chapter 9.
 - Chair Lieber reported that the Planning Board has drafted new bylaws re: street numbering and that he had reached out to suggest collaboration with Bylaw Committee for the purpose of consistency.
 - 36-1 Annual Town Meeting (TM)
 - Ann Santos suggested to strike out "the first Monday following Town election" to give TC more flexibility to set the TM within the purview of the Charter. New language suggested: "at a meeting set by the Town Council per the Town Charter" or similar wording approved by Town Counsel Tom Mullen.
 - 36-2 add that announcement for TM should be posted prominently on Town Website
 - 36-3 Chair Lieber suggested whether changing to "majority" should be contemplated. Tom Mullen suggested language should stay "as is" in favor of status quo.

- Chair recommended adding language requiring consent agenda. (Items in consent agenda can by taken out of order at TM unless there is an objection). Chair Lieber stated he would look at surrounding communities for language on consent agendas.
- 36-4 Rules of Conduct
 - Ann Santos and others suggested change in language "every person shall stand" to reflect some may not have the ability to stand. Discussion re: adding language for accommodations for those that cannot stand. Chair Lieber will reach out to the Commission on Disabilities for guidance.

- 36-7 Discussion on declaration of votes and that the Moderator can call the vote on a 2/3 vote. However, if 7 or more voters request an exact count, Town Moderator would call for an exact count. Discussion that 7+ voters' rule is not well known and it should be published to provide transparency for minority (number) speakers. Chair Lieber suggested we could provide a link to Chapter 36 and post on Town Website when Town Meetings are announced. Discussion about possibility of including Chapter 35 citation in publication of warrant.

<u>Item #5: Update on Professional Assistance with Zoning Recodification:</u>

- Tom Mullen reported on discussions with Mr. Mark Bobrowski. Tom reported that Mr. Bobrowski came highly regarded and willing to recodify our bylaws for \$45,000. Mr. Bobrowski reported that our bylaws are "in good shape" in his opinion. He would guarantee to meet with our Committee, et al, 4 times.
- The Bylaws Committee authorized Steve Maio, Chair Lieber, and Tom Mullen to review the contract before it is finalized.
