- MBTA Accessibility Mtg: Lois attended the meeting. Lois commented on the inaccessibility of the Wakefield MBTA station. The MBTA did not have any comments about the station. The meeting focused on the readability of the MBTA signage. Janice wondered if the MBTA would be willing to make more handicap parking spaces at the Melrose Highland station, which is accessible. Lorna added on that we could have more accessible parking at the Reading station as well.
- New Commission Member we are waiting for the Town Council to vote on their membership.
- Update on Intelligent Lives including invitational flier, and tasks -
 - Lois suggested that we have someone at the door, opening the door and directing people to the event. Janice volunteered to do this job.
 - Advertising The event has been on the FB page, as well as on WCAT, the newspaper, the kiosks downtown, and etc. Levonne suggested asking the Item to cover the event so that the issue of employment gets more press coverage following the event.
