Old/New Business Summaries, discussions and updates

Welcome to new commission member Judy Tanner.

Discussion with Bill Renault (BR)

- Accessibility of the town playgrounds (for people with mobility issues) reported by Judy Tanner, the 2 playgrounds around the lake are accessible. JJ Round and Mapleway playground has accessibility issues. Judy Tanner will email photos and a more detailed description of the issues to BR and he will investigate the two playgrounds in question.
- Lorna asked for an update on the accessible swing BR said that one of the school's playgrounds was being updated this year and will include an accessible swing. Lois advocated that the commission has been asking for a swing for many years. BR is going to look into the swing issue further and update us at our next meeting.
- The commission received an email about accessibility of a school event for the deaf and hard of hearing. BR did not get a copy of the complaint but will follow up with the school department once he receives that. Marie will forward the complaint to BR.
- Lorna asked BR about the meeting's public announcements in the newspaper. BR will follow up about when, who, and how the announcements are being posted to be sure that the public meeting laws are being followed.

De-brief - Intelligent Lives

- What worked/what could we have done better?
 - o The movie got positive feedback from attendees.
- How do we continue the discussion?
 - o Rotary is interested in having members of the commission come to one of their meetings to show a clip from the movie and discuss the issue of employment of people with disabilities. Levonne will follow up on this.
 - o Discussion of asking WCAT to create a presentation for groups like Rotary and the Chamber of Commerce.
 - o The resource list that was made for the event could be added to the commission website.
 - o Discussion ensued about hiring practices of the Town for town positions. Are the town's hiring practices fair? For example, the town is requiring all summer position hirees to have a driver's license, even if the position does not require driving. This

policy would eliminate many people with disabilities from the positions. Does the town actively recruit people with disabilities?

• Discuss the possibility of sponsoring an annual visibility event

MBTA discussions

- Letter sent regarding accessibility at Wakefield Station
- Judy attended an MBTA meeting on 4/28/22. She presented this update to the commission: Transit Ambassadors are posted at MBTA stations that help with rerouting of trains and buses but also help with requests for assistance. The MBTA is keeping an updated listing of elevator service (which are running and which are not). The Ride Flex is a new program for people that are eligible for The Ride. They are partnering with rideshare companies to reimburse ride costs for people. The rideshares have a much shorter wait time for people. The Ride program is still available. For questions about this program and for trouble with Charlie cards call 617-222-3200. Marie requested that this information be added to our website on the town page and would connect with Jenn McDonald.
- Lois said that the MBTA announced that they have a 5 year plan (CIP) to update stations that
 are not accessible of which Wakefield is one of the 21 stations that are not accessible. The
 MBTA has not committed which stations will get updated yet. Lois will continue to work on
 this issue with the MBTA by attending public meetings and meeting with local
 representatives.
