Old/New Business

- Disability traffic signs Paula Marie did not hear from the family regarding the signage on their road. Committee considers this action item complete for now.
- Website update Maeve & Paula Maeve and Paula met with Ms. McDonald regarding the website and developed some brief categories to organize the resources. They will share a draft at next month's meeting.
- Closed Captioning Maeve

Committee reaches out to the ADA coordinator-William Renault and he will coordinate the effort. There is money in the town budget to pay for this.

• Sidewalk issue on Vernon St. near Dolbeare School

Maeve shared that they put in a new curb cut Vernon, Mansfield and sesame. It is getting really muddy and icy in those areas could be looked into. Bill reported that a there is a new contract to address the new curb ramps and will be redone to build new sidewalks. There will be a new sidewalk from Sesame to Townline road.

• Continue discussion related to Intelligent Lives

We can do it over Zoom and maybe a Tuesday or Wednesday night would be good if we need to use the Communitas Zoom unless we need to use the town account. We will confirm with Sherri if we need to use the town Zoom account. We will try for 4/13 or 4/15. We will discuss panel and discussion activity to conduct after the meeting utilizing the different features in Zoom.

• Update on Banner

Lois shared an example of the banner that the T-stop can create for our events. The committee is recommending to change the name to Commission on Disabilities. Bill will look into the process for changing our names.

• Goals and By-laws

We do not have specific goals and by-laws for our commission. A decision has to be made about whether we want to work with town council to write up by-laws with town council. Bill recommends that make adjustments to the current charter vs writing by-laws. We will make a formal decision and vote on this at the next meeting when Levonne is in attendance.
