Public Participation

Chris Carino – Albion Cultural Exchange

Chris reported on the grant the art center received to ensure that it is accessible. The building was built on 1910. In the last year, new bathrooms, fully ADA compliant, wheel chair accessible were installed. Next, working on entrance to be more accessible from the Chestnut Street side of the building. Elevator, artist work spaces and classrooms on the top floor and storage in the basement. They are about to go out to bid for the construction on the new entrance including a new automatic door. Funding for updating the Albion street entrance will need to happen at a later date due to funding issues and the magnitude of the project. The committee believes the decisions made so far to make the building more accessible were appropriate. The goal is to make the back entrance a more appealing main entrance for the building. Signage will be used to identify the rear entrance. Maeve confirmed that the edges or change in grade will be identified by a bright color. Chris will invite the committee to visit the site and provide feedback.
