----- TOPICS OF DISCUSSION -----

Call to Order	The meeting was called to order at 7:06 p.m.
Public Participation	<p>Carol Zoubek provided an update on the efforts to restore the lawn of the First Baptist Church.</p> <p>Melissa Eusden is interested in getting a Styrofoam ban in Wakefield; a ban similar to ban that recently passed in Melrose, MA.</p>
Approval of Minutes, December 2019	M. Session made motion to accept the minutes for meeting, S. Veilleux seconded. All approved.
ESC Events	R. Darnell proposed office hours for the committee. He has reserved a room at the Americal Civic Center. The goal is to receive input on local sustainability issues from Wakefield residents and businesses representatives. The date of office hours is January 23 rd .
Town Meeting	R. Darnell will research how to file a request to get a warrant on a Town Meeting R. Darnell will contact Melrose Zero Waste on the language of their recent ban addressing wate.
2020 Calendar	Town Recycling hazardous waste, e-collection, and composting collection event is being organized for May 2, 2020.
Guiding Principles	Draft of the principles is with town consultant KLM for their review and offer suggestion on how to align the principles with the Wakefield Evaluation Framework. Comments are expected in a few weeks.

Municipal Solar

WMGLD has identified two DPW properties at Crystal Lake for a potential 25kW solar installation that would make use of a state grant. The buildings are being structurally evaluated.

WPS Updates

Next week is the State of School presentation by the School Superintendent. The presentation will outline the superintendent's budget priorities.

S. Veilleux and R. Darnell are working on estimating the cost to change from styrofoam to compost trays. L Sheridan suggested that folks advocate for the high school to accommodate using reusable serving trays, utensils, etc. during the MSBA high school project.

Food Rescue and composting program expanded to the elementary started earlier this month. There has been an average of 250 items collected and composting 110 pounds a day. The funding grant covers the costs for rest of school year.

DPW Update

DPW received a state grant on Albion Street for sidewalk, walkability, street trees, and other improvements. Scope based on comments from the enVision planning process.

DPW working on a grant application for drainage and sidewalk improvements along Lake Quinnapowitt from Town Hall to Honey Dew. Grant will be submitted this spring.

J. Conway noted that there should be more street trees planted in the future through the revived town CommuniTREE Program.

R. Darnell noted that Litterati app tracks location and pick up litter collection. The app shows litter in Wakefield. <https://www.litterati.org/>


