- II. Public Participation Sue Herz
  - A. Holocaust Forum
    - 1. It will be presented on Zoom, Thursday, April 28<sup>th</sup>, which is International Holocaust Memorial Day, and feature 5-6 speakers, all adult children of Holocaust survivors.
    - 2. It is currently sponsored by the Melrose HRC and Melrose Clergy Association
    - 3. Would WHRC be willing to sponsor?
    - 4. A motion was made to co-sponsor the Holocaust Memorial Event, seconded and all voted in favor.
  - B. Conversations About Whiteness
    - 1. The next 5 week (Thursdays, 7-9 p.m.) course begins March 3<sup>rd</sup>
    - 2. Please spread the word.
  - C. Promoting these events
    - 1. The WHRC doesn't have an email list
    - 2. No town group can send out email individually technological issue?
    - 3. This could be revisited especially after our experience with the pandemic.
- III. Guest Speaker Jim Bennett
  - A. General information
    - 1. His specialty is indigenous history.
    - 2. He encourages us to seek out the council of indigenous people.
    - 3. In having a land acknowledgement statement, are we getting into a performative thing or something substantive and very important?
    - 4. He noted that the Wakefield town seal does acknowledge Quannapowitt with the image of a native man.
  - B. A brief history of the town's relationship with the indigenous population
    - 1. The place we call Wakefield has 12,000 years of history.
    - 2. So many different peoples lived here before the Europeans arrived.
    - 3. He presented Wakefield's first family's family tree.
    - 4. Earliest known map of Wakefield was created in 1634.

- 5. 1928 Territorial Subdivisions and Boundaries map reveals who originally held the
- 6. 1637/9 Squaw Sachem, "Massachusett's Queen", signed away her people's deed to their land which includes Wakefield.
- 7. In 1644, the signing of the Submission of Tribal Leader Agreement gave away sovereignty and submitted to European rule.
  - a. James Quannapowitt, a grandson of the first family, was brought to Wakefield to sign the deed.
  - b. Suggestion: acknowledge him with a sign by Lake Quanapowitt.
  - c. He had been living in the "praying town" of Natick as a result of the forced removal of indigenous people.
- 8. Colonization pitted the peoples against each other.
- 9. We would like to know who lived here.

The Massachusett at Ponkapoag were here when the Puritans arrived.

- 10. How can we highlight this history?
- C. WHRC Land Acknowledgment statement
  - 1. We reviewed and discussed it.

    Change term "stand with" to not imply physical ability.
  - Proposal: Read it at the beginning of every WHRC public meeting, adding changing additional information to raise awareness, acknowledge current events/activism, provide context and history, etc.
  - 3. Suggestion: Try to influence other Town bodies to do the same.
  - 4. Discussion: Should the town have one statement or each group create their own or should all use our core statement followed by their priority?

ACTION ITEM: Benny Wheat and Eileen Rooney will seek input/approval from the Massachusett/Ponkapoag people before finalizing and releasing the statement.
