1. Call to order and Roll Call
2. Public Participation: None
3. Minutes: Voting on November minutes tabled until quorum can be met at the January meeting.
4. Financial Report: **Jess to reach out to Lori and Diana from the Arts Council about being reimbursed on the grant use** and determine the deadline for reimbursement submissions for this year.
5. Position statement:
 - a. A discussion was held but in light of the holidays, a quorum was not met to vote

 - e. If another organization in town is holding an event and asks for support or if a member of the public attends a meeting and requests support or a response, we could consider it.
 - f. TBD: **Sherri to set a meeting with Steve Maio to discuss support and guidance** from town leadership and town council liaisons.
 - g. Possibly post an article in the item about the WHRC mission

 - a. Commission members considered public input from Julie Scott and discussed any additional responses to the Town Flag policy
 - b. Note: Currently, there is only one flag pole at Town hall and the Americal Center is one of the few town buildings with more than one flag pole.
 - c. The consideration of adding flag poles to Town Hall or other town buildings and determining the cost of doing so, sits with the town council and the WHRC has nothing further to add to the flag policy at this time.
