



Parking Violation Appeal

To appeal of a parking violation, fill out the form on the following page or submit a request online at https://wakefieldma.rmcpay.com. Appeals not submitted online must be sent to the Office of the Parking Clerk at 1 Lafayette Street, Wakefield, MA 01880 or by email to kstache@wakefield.ma.us. Please include a copy of your violation and all supporting documents you wish to be considered along with your form.

First appeal: Your first appeal must be in within 21 days of the violation date.

Second appeal: If you are not satisfied with the decision of the hearing officer, you may make an appointment for an in-person hearing by calling 781-246-6330. Hearings are held at the Office of the Parking Clerk in Wakefield's Town Hall.
