ITEM 3 | MBTA Communities Update – Public forum

Jim Hogan presented information to the public before public participation/feedback.

Benny Wheat – 44 Meriam St - 10% affordable housing, doesn't Wakefield have already? What does a third-party feasibility study look like?

Marie Rej – 25 Montclare Ave – representing disability community - any incentives offered to residents the ability to expand 2 family to 3 family expansion or adding in-law apt? Jim Hogan - Site plan approval process would need to take place.

Chris - 50 Emerson St – 15 units per acre. 10 units - 10% for affordable housing?

Frank Conte – 11 Second St – zoning state mandate 18% vs 10%. What is Wakefield not doing to require the State to say we can't do this anymore. What is the town giving up as far as zoning authority? Any thought been given to where the district may be established? Wakefield is a commuter rail community with possible zoning areas being around Downtown or Greenwood. Wakefield needs minimum 114 acres.

Chair Theo Noell – concept of missing middle housing what are people's reactions?

- Benny Wheat – all about medium housing, nice middle ground for Wakefield, concerned about slightly larger buildings. Looks forward to slightly denser neighborhoods.
- Frank Conte – average medium income in Wakefield? Will this be economical for a developer?

Erin Kokinda – Mass Housing Partnership has webinars for 3a if residents are looking to learn more.
