Bill Spaulding – plans to attend ZBA meetings as a resident regarding the Vocational School. Matt Lowry concerned about trucking routes. Jim Hogan – regarding Dover Amendment, PB will leave this up to ZBA and Building Inspector. As residents of Wakefield PB members will be active with this process.

Bill Spaulding – 117 Albion St and IFly on Audubon Rd

Erin Kokinda – spoke about the IFly on Audubon Rd. They have met with Conservation regarding water shed, wetlands, run off, river in the area.

Bill Spaulding – TC meeting - regarding housing production strategies TC to work with PB regarding affordable housing trust – no timeline has been set. TC voted to appropriate up to \$100,000 for a new



Strategic Growth position. Bill would like PB to come up with an outline of what this position would look like. Will discuss again after the vote at Town Meeting.

Theo Noell – the last master plan survey closes March 20<sup>th</sup>. Erin Kokinda, Master Plan report should be published sometime late summer.
