July 2020 Highlights

On July 8^{th,} Wakefield Detectives worked with the Massachusetts State Police and the Department of Homeland Security on a large scale drug delivery that had been tracked from Germany to the UPS Store on Lincoln Street. Based on the long-term investigation, individuals were expected to pick up a package sometime on this date. Surveillance teams were set up and at approximately 1:00 pm one male party entered the store and signed for the package which contained 8,000 grams of ecstasy worth approximately \$300,000. Two accomplices were located in the vicinity. The three male parties out of New York were arrested and taken to our station for booking. All three men are facing drug trafficking charges.

On July 11th Sergeant Matt Powers was monitoring traffic on Farm Street when he observed a vehicle traveling inbound at approximately 60 MPH. He was able to quickly get behind the vehicle and conduct a traffic stop. As he spoke with the female operator, he detected a strong odor of an alcoholic beverage and she appeared dazed and confused, not realizing that he was standing next to her. He was able to get her attention and began a conversation. Following a series of field sobriety tests, the operator was taken into custody and charged with OUI Liquor. On July 20th Sergeant Jon Burnham was walking through the parking lot of the Wakefield Co-Operative Bank when his attention was drawn to a Jeep Compass parked on the sidewalk. He walked over and observed a female party in the driver's seat moving items around the compartment. He asked her about the parking situation and during this time he detected a strong odor of alcohol and her speech was slurred. Following a series of field sobriety tests, she was taken into custody and charged with OUI Liquor (3rd Offense).

On July 22nd officers were dispatched to the parking lot at Landrigan Field for a report of a missing female. They were met by a male party who advised that his 22-year-old niece was missing and her vehicle had been located in this parking lot. It was believed that she was depressed and had walked into Breakheart Reservation. Multiple officers went into the reservation and began a search. Shortly thereafter Officer Ryan Doran was able to locate the female on the top of a steep trail. She required immediate medical attention and with the assistance of ambulance personnel they were able to carry her out and down to the ambulance. She was transported to the hospital where she was able to recover.

On July 23rd officers were dispatched to Railroad Avenue for a report of a suicidal male. Upon arrival, they observed a male and female outside of an apartment. When the male noticed their presence, he took off running into a heavy brush area. Officers were able to confirm from the female that this was the male party in question. They were able to talk the male party out of the brush area where they continued conversation. He agreed to go to the hospital and the ambulance arrived. At that time he took off running again down the abandoned railroad tracks. Sergeant Powers was able to catch up and secure him so he would not cause any injury to himself. Officer Pelletier was able to apply for an emergency evaluation and the male party was taken to the hospital without further incident.

Throughout July our team worked with an adult male and female that are in a dating relationship that involves domestic violence, substance use, pregnancy, and mental health issues. This has involved multiple patrol officers, Family Services Officer Rando, our clinician Jennifer, and our Recovery Coach Tracy. This is a complex case that has and will require much time, effort, and safety planning. With much talk of incorporating social services that has been in the news recently, this is a prime example of not only the work that we already do but also the importance of a team that involves the police. Many of these cases are not safe to be handled by social services alone and the need for at least one officer if not more is critical to the well-being of all involved.

We would like to congratulate Officer Ryan Doran for receiving the most recent "Officer of the Quarter" award. On May 8th, Officer Doran was conducting property checks on Foundry Street during the early morning hours when his attention was drawn to a white work van with an individual inside parked in the back of 101 Foundry Street. This property abuts a construction site at 69 Foundry Street. On March 9th there had been a breaking and entering of this site where a larceny of several thousand dollars of tools occurred during the overnight hours. Officer Doran recalled video footage from that incident of a thin white male operating a white van with no company lettering, a black ladder rack, and a metal roof cargo box. Officer Doran pulled into the lot and approached the van. The male operator did not have a plausible explanation for being on the property. His appearance and the exterior of the van both matched the video footage from the previous larceny. Several tools were located in the van that matched descriptions of the stolen items. Following the investigation, this male party out of Stoneham was linked to the previous crime in Wakefield as well as other larcenies. As a result of this case we were able to obtain search warrants and recover thousands of dollars of worth of stolen tools. The tools were returned to some very happy construction workers.

On July 9th, we welcomed the newest member of the Wakefield Police Department, Officer Adam Smigielski, to our ranks. Adam is a veteran of the United States Army and currently lives on Lake Street in Wakefield. Adam started the police academy on January 6th and had been expected to graduate in early June. However, due to COVID-19, the police academy was forced to close for one month. Adam and the rest of his classmates were finally able to finish the police academy on July 8th and we had him in the next day to get sworn in. Adam's badge was pinned to his uniform by his father Mark, who has been a police officer in the town of Newbury for over twenty years.





Arrests On View & Based on Incident/Warrants By Race / Sex











CRASH LOCATIONS JULY 2020




STREET LOCATION




