Re-Takes: "Implementing procedures for students to retake and redo summative assessments, and considering the more recent (and therefore more accurate) score, motivates students to learn from mistakes and increase their competence and understanding."

"There are many options and complexities with implementing retakes. Some decision points include what qualifies a student for a retake, when and how they will be offered, for how long students can retake, and who decides and develops the retake's content and assessment to ensure validity. Retakes are only truly equitable when they are required, not just optional, for students who show less than mastery of course content." (181-182)

Late Work: "As much as we want students not to miss deadlines, and certainly never want them to cheat, when we incorporate these (mis-)behaviors into a grade, we warp the accuracy of the grade to describe student academic performance. We also miss the underlying cause of the behavior- such as inadequate preparation and insufficient supports. Instead of entering a low grade that effectively ends the learning, we should allow late work to be submitted when it is done."

Effort and Participation: "It is inequitable to include student behaviors in a grade. Weighted categories such as Participation and Effort reward and punish students based on subjective criteria and are flush with opportunities for implicit biases. Instead, when these categories are not included in a grade, students can be taught how participation are means for learning, not ends in themselves" (125)
