BOARD OF SELECTMEN – April 24, 2017

The meeting of the Board of Selectmen was posted and held at the WCAT Studios, 24 Hemlock Road, Wakefield, MA, with Chairman Patrick S. Glynn presiding, Selectman Paul R. DiNocco, Selectwoman Phyllis J. Hull, Selectman Brian E. Falvey, Selectwoman Ann McGonigle Santos, Selectman Peter J. May and Selectman Anthony Longo in attendance. Town Administrator Stephen P. Maio and Clerk to the Board of Selectmen Sherri A. Dalton were also present. Town Counsel Thomas A. Mullen was absent.

Chairman Patrick S. Glynn called the meeting to order at 7:00 p.m.

No one was present for Public Participation.

Selectman DiNocco motioned to approve the minutes of April 10, 2017, seconded by Selectwoman Hull and so voted.

Selectman DiNocco motioned to approve the executive minutes of April 10, 2017, seconded by Selectman Longo and so voted.

Selectwoman Hull motioned to approve the donation from the Star of Bethlehem Lodge to the Veteran's Memorial fund, seconded by Selectman Falvey and so voted.

Selectman DiNocco motioned to approve the request from the Lucius Beebe Memorial Library to accept and expend a gift or gifts to the Library in the amount of \$8,920.00 from various donors with thanks, seconded by Selectwoman Santos and so voted.

Gerard Leeman, Chairman of the Finance Committee appeared before the Board to as for permission to hang a photo of long time Finance Committee member Phil McCarty in the first floor conference room at Town Hall. Chairman Glynn motioned to approve the request of Gerard Leeman to hang a photo of Phil McCarty in the first floor conference room at Town Hall, seconded by Selectwoman Santos and so voted.

Marianne Cohen, Director of the Wakefield/Lynnfield Chamber of Commerce and Laurie Hunt appeared before and stated that the Chamber is opposed to the citizen petition for the Plastic Bag Bylaw Article which will be presented at Town Meeting on May 1, 2017.

Town Administrator Stephen P. Maio updated the Board regarding the First Amendment to Wakefield Amended and Restated Sewer Agreement for Market Street in Lynnfield. In April of 2008, the Town, MWRA and National Development signed an Agreement to provide the connection to the sewer system for the new development through Wakefield to the MWRA system. At that time there were repairs to the Sheraton Colonial system that were required. There was a \$100,000.00 payment from National Development for existing issues and a \$509,000.00 remediation payment from National Development. There was also a 1.5 million dollar payment to Wakefield and a \$100,000.00 payment to Wakefield for attorney fees. The Agreement allowed for National Development to produce 76,350 gallons a day through the Wakefield system. With all the development at Market Street the actual gallons a day is at 97,643 and there will be more as things get added. Over the next month or so Town Administrator Maio will be meeting with National Development and members of Lynnfield to talk about this.

Selectman Falvey motioned to appoint James Scott of 75 Elm Street and William Butler of 71 Elm Street to the Lake Quannapowitt Subcommittee, seconded by Selectman DiNocco and so voted.

Selectman DiNocco motioned to approve the request of Erin Fopiano for a One Day Liquor License on June 10, 2017 from 5:00 p.m. until 8:00 p.m. at the Hartshorne House, seconded by Selectman Falvey and so voted.

Selectwoman Santos motioned to approve the request for Diamond Enterprise Corp. for a Common Victualler License at 39 Tuttle Street, seconded by Selectman Longo and so voted.

Selectman Longo motioned to approve the request from Aaronap Cellars LLC for a Liquor License for the Farmer's Market, seconded by Selectwoman Hull and so voted.

At 7:30 p.m. Selectman Falvey motioned to open the Public Hearing for Verizon New England Inc. and Wakefield Municipal Gas & Light Department to relocate poles, wires, cables and fixtures, including anchors, guys and other such necessary sustaining and protecting fixtures, along and across the public way or ways on Main Street at pole number 15, seconded by Selectwoman Hull and so voted.

The utility pole is right in front of the site and the request is to move the pole 33 feet to the edge of the property. No one from the public spoke in favor or against the request.
