BOARD OF SELECTMEN - October 24, 2016

The meeting of the Board of Selectmen was posted and held at the WCAT Studios, 24 Hemlock Road, Wakefield, MA, with Chairman Patrick S. Glynn presiding, Selectman Paul R. DiNocco, Selectman Brian E. Falvey, Selectwoman Ann McGonigle Santos, Selectwoman Phyllis J. Hull, Selectman Anthony Longo and Selectman Peter J. May in attendance. Town Administrator Stephen P. Maio, Clerk to the Board of Selectmen Sherri A. Dalton and Town Counsel Thomas A. Mullen were also present.

Chairman Patrick S. Glynn called the meeting to order at 7:30 p.m.

Selectman DiNocco motioned to approve the minutes of the October 12, 2016 seconded by Selectwoman Santos and so voted.

Selectman May motioned to approve the request from the Event Planning Committee to conduct the Holiday Stroll on Saturday, December 3, 2016, between the hours of 3:00 p.m. and 7:00 p.m. (Street closing to occur at 1:00 p.m.) (Actual event time is 2:45 p.m. with the start of the Parade at the Civic Center), seconded by Selectwoman Santos and so voted.

Selectman Falvey motioned to approve the request from the Event Planning Committee to close Main Street to vehicular traffic from Yale Avenue to Richardson Avenue/Lincoln Street and to close Albion Street to vehicular traffic from Main Street to North Avenue. The Committee will meet with the Town's logistics team as required prior to the event to ensure vehicular and pedestrian safety, seconded by Selectman May and so voted.

Selectman May motioned to approve the request from the Event Planning Committee to utilize the area surrounding the Civic Center and part of Armory Street at the commencement of the Parade (there will be a rolling shutdown from the Civic Center to Lincoln Street starting at 2:45 p.m.) and Lincoln Street parking lot for Stroll activities, if needed, seconded by Selectman Longo and so voted.

Selectman DiNocco motioned to set the Public Hearing for November 14, 2016 at 8:00 p.m. for Tax Classification to reaffirm the vote since the Public Hearing was not advertised for in the newspaper, seconded Selectman Longo and so voted.
