Selectman Good motioned to approve the Woodville bond in the principal amount of \$34,000.00 and interest amount of \$\$3,267.00 be transferred, seconded by Selectman Glynn and so voted. Town Administrator Stephen P. Maio noted that the end date of this bond is 2021.

Selectman Good motioned to approve the Dolbeare bond in the principal amount of \$522,000.00 and interest amount of \$52,359.75 be transferred, seconded by Selectman DiNocco and so voted. Town Administrator Stephen P. Maio noted that the end date of this bond is 2020.
