DiNocco, Selectman Patrick S. Glynn and Selectwoman Phyllis J. Hull in attendance. Town Administrator Stephen P. Maio, Town Counsel Thomas A. Mullen and Clerk to the Board of Selectman Sherri A. Dalton were present. Selectwoman Betsy Sheeran was absent.

Chairman Brian E. Falvey called the meeting to order at 7:03 p.m. and stated that there is a need for executive session to discuss contract negotiations because an open meeting may have detrimental effect on the bargaining position of the Town with the intent of returning to open session.

Selectman Glynn motioned to approve Article 23 – Wakefield Building Trust in the amount of \$5,650.00, seconded by Selectman DiNocco and so voted.

Selectman Doto motioned to approve the three year July 1, 2015 – June 30, 2018 Department of Public Works Laborers' contract as presented by Stephen P. Maio, seconded by Selectman DiNocco and so voted.

Sandra Cleary on behalf of the MBTA was before the Board and presented an offer for a free shelter from the MBTA for inbound bus commuters in Wakefield Square. She told the Board that it would be an aluminum and tempered glass shelter and would be situated in front of Farm Land. The Selectmen did not like the look of the shelter saying that it did not fit in with the efforts to improve the appearance of the downtown.

Selectman Glynn motioned to deny the request from the MBTA for a free shelter, seconded by Selectman Doto and so voted with Selectman DiNocco recusing himself.

Selectman DiNocco motioned to approve the request from Sharon Gilley, Director of the Lucius Beebe Memorial Library to accept and expend a gift or gifts to the library in the amount of \$965.00 from various donors with thanks, seconded by Selectman Doto and so voted.

Selectman DiNocco motioned to approve the request from John J. McCarthy, Jr. Town Treasurer to transfer \$327,373.88 from the Town's Capital Project's account to the general account so bond payments can be made on April 15, 2015 as follows: Dolbeare interest \$31,610.25; Woodville interest \$1,917.00; Woodville interest \$81,978.75; Senior Center interest \$8,383.50; Galvin Middle School interest \$203,484.38, seconded by Selectman Doto and so voted.
