Public Participation

There was no Public Participation.

Regular Minutes - May 31, 2018 Councilor DiNocco motioned to approve the Regular Board Minutes of May

31, 2018. Councilor Longo seconded. Motion passed 6-0-0.

Councilor Santos joined the meeting at 6:32 p.m.

Regular Minutes – June 11, 2018 Councilor Butt motioned to table the Regular Board Minutes of June 11, 2018.

Councilor DiNocco seconded. Motion passed 7-0-0.

Executive Minutes – June 11, 2018 Councilor DiNocco motioned to approve the Executive Minutes of June 11,

2018. Councilor Longo seconded. Motion passed 7-0-0.

National Grid
- Grant of
Location
Easement

Members of National Grid along with Director of the Department of Public Works Richard Stinson and liaison to the Department of Public Works Councilor Smith-Galvin spoke regarding the Town of Wakefield National Grid underground 345 cable KV project requirements. Councilor Smith-Galvin motioned that the Town Council approve the "Grant of Location / Transmission Line Franchise" presented by the Director of Public Works in response to the petition dated November 3, 2017 and filed by New England Power Company d/b/a National Grid (the "Company") on the terms and subject to the conditions set forth in the said Director's letter of today's date to the Company entitled "Town of Wakefield National Grid underground 345 cable KV project requirements," which letter the Town Council hereby approves and authorizes the said Director to sign and deliver on behalf of the Town. Without limiting the generality of the foregoing, the said project shall be located in the following streets: Albion Street, from the Stoneham Line to Broadway; Broadway, from Albion Street to North Avenue; North Avenue,

from Broadway to approximately the Railroad Tracks in the vicinity of Jiffy Lube: Across Main Street, from the west side of Main Street at the Railroad Right-of-way at Bennett Street; Across Bennett Street, from the south side of the Railroad Right-of-Way to the north side of the Railroad Right-of-Way; Across Richardson Street, from the Railroad Right-of-Way to the Railroad Right-of-Way; Across Water Street, from the south side of the Railroad Rightof-Way to the north side of the Railroad Right-of-Way; Across New Salem Street, from the south side of the Railroad Right-of-Way to the north side of the Railroad Right-of-Way; Across Fitch Court, from the south side of the Railroad Right-of-Way to the north side of the Railroad Right-of-Way; Salem Street, From the Railroad Right-of-Way at Nablus Road to Montrose Avenue, and; Montrose Avenue, from Salem Street to the entrance of the National Grid Substation located on/off of Montrose Avenue. Councilor DiNocco seconded. Discussion ensued regarding the allowed days and hours of work. Councilor Dombroski motioned for a 9:00 a.m. start time on Saturdays. Councilor Butt seconded. Motion failed 2-5-0 with Councilor Dombroski and Councilor Butt voting in favor of the motion and Councilor Smith-Galvin, Councilor Longo, Councilor May, Councilor DiNocco and Councilor Santos voting against the motion. Main motion passed 6-1-0 with Councilor Smith-Galvin, Councilor DiNocco, Councilor Santos, Councilor Longo, Councilor May and Councilor Butt voting in favor of the motion and Councilor Dombroski voting against the motion.

#### Public Hearing – Water and Sewer Rates

At 7:00 p.m. Councilor DiNocco motioned to open and postpone the Public Hearing for the Water and Sewer Rates until after the National Grid Grant of Location Easement discussion. Councilor Santos seconded. Motion passed on a Roll Call vote with all seven (7) councilors voting in favor.

At 7:07 p.m. the Town Councilor entered into the Public Hearing for the Water and Sewer Rates. Director of Public Works Richard Stinson appeared before the Council to present the Fiscal Year 2019 water and sewer rates as recommended by the Advisory Board of Public Works. Councilor DiNocco motioned to approve the water rate of \$7.20 per 100 cubic feet and the second meter base charge of \$18.00 plus current water rate per quarter as presented. Councilor Santos seconded. Motion passed 7-0-0. Councilor DiNocco motioned to approve the sewer rate of \$11.35 per cubic feet as presented. Councilor Santos seconded. Motion passed 7-0-0. Councilor DiNocco motioned to approve the sewer flat rate of \$340.50 per quarter as presented. Councilor Santos seconded. Motion passed 7-0-0. Councilor DiNocco motioned to approve the septic disposal rate fee of \$110.00 per delivery as presented. Councilor Santos seconded. Motion passed 7-0-0. Councilor DiNocco motioned to approve the meter fee of \$50.00 per quarter after three (3) unsuccessful letter attempts. Councilor Santos seconded. Motion passed 7-0-0. Seeing that there were no members of the public present, at 7:30 p.m. Councilor Santos motioned to close the Public Hearing. Councilor Longo seconded. Motion passed 7-0-0.

#### Nahant Street Yard Waste

Councilor Dombroski proposed adding a total of ten (10) Saturdays and Sundays to the current 2018 Nahant Street Yard Waste Facility schedule.

#### **Facility**

Councilor Dombroski motioned to add July 14th, July 28th, August 11th, August 18th, September 8th, September 15th, September 23rd, September 29th, October 13th and October 28th to the current 2018 Nahant Street Yard Waste Facility schedule as a pilot program. Councilor DiNocco seconded. Motion passed 7-0-0.

#### Reserve Fund Transfers

Town Administrator Stephen P. Maio presented to the Town Council the Reserve Fund Transfers totaling \$283,103.00 for Fiscal Year 2018.

# Proposed 40B - Greenwood Station

The Council is in receipt of a letter from MassHousing regarding the proposed 40B development at 998-1000 Main Street in which the Council can submit their comments to MassHousing regarding the application from the developer by July 18, 2018. The Councilors agreed to draft a letter to MassHousing and to also have the developer attend the July 16, 2018 Town Council meeting.
