Project Updates: Lake Boating Concession: Anthony Guardia from the Boys & Girls Club of Stoneham & Wakefield provided an update about this summer's community boating program at Lake Quannapowitt. The program opened on June 26th, 2021 and closed for the season on October 10th, 2021 with approximately 2,300 boating renters. Wakefield Main Streets created, funded and distributed coupons to boaters to encourage economic growth for downtown merchants. The program provided Wakefield teenagers with 1000 hours of Summer employment. **COVID-19:** Health Director Chui provided an update on the COVID-19 situation in Wakefield. Cases are increasing with an average of 9 cases per day. Director Chui stressed the importance of getting tested if you have symptoms and getting vaccinated if you haven't already done so.
